Each FFA Chapter or County 4-H may enter as many teams as they wish. Each team will be comprised of 3 or 4 members with the 3 highest scores used for tabulation. Individuals may also judge.

AGE DIVISIONS:

Junior Division 8th grade or below.

Senior Division 9th – 12th grade.

Younger students may move up to the Senior Division if necessary, but older students cannot move down. There will be no separate divisions for 4-H and FFA

FORMAT:

Twelve placing classes and one questions class.

Students, Chapters, or Clubs should bring their own scantrons. Scantrons will be available to purchase onsite for \$1.00/sheet if needed.

Contest Officials will place and give reasons at the conclusion of the contest.

Texas FFA CDE Rules will apply!

County animals, including Sale animals, may be used in judging contest.

INDIVIDUAL AWARDS:

Hi-Point Junior & Senior receive Belt Buckles

2nd – 10th will receive plaques

TEAM AWARDS:

The top five teams in each division will receive plaques.

ENTRY FEE:

\$20.00 per team OR

\$5.00 per individual.
